B. Interim CEO

Vaughn Salabye stated that one bus is currently equipped with Wi-Fi. He is working on getting another bus equipped. He gave a report on his activities in the month of August. Administration is monitoring student engagement. He is also monitoring lesson plans. He is also looking at PLC's in instruction, and there are 15 dual enrollment classes. He plans to report staff attendance as well as student attendance. Recruitment is ongoing. Testing will be ending next week. The main objective has been reached in readiness of the facility. Three meeting have been held with teachers for professional development. All departments are working together in unity to help students and one another. G= growth, A=acceptance, H=hardwork, S=safety. Volleyball, Cross-Country and Chess are taking place now. Plans are process for teacher recruitment and retention, updated evaluation tools, and tutoring. He would like to see policy updates at the next work study session.
